## Apical Group Hands Over Newly Renovated Schools to Balikpapan Government



**Balikpapan, Kalimantan, 27 May 2021** – Apical Group, a leading exporter of sustainable palm oil, today officially handed over two renovated school buildings to the Balikpapan City Government.

Apical Group, a member of the RGE group of companies, supported the renovation project of the two schools in Teluk Waru, Kariangau, West Balikpapan. The renovation covered classrooms, teachers' and principals' offices, roads, car parks, toilets, and sports facilities.

Additionally, Apical Group also collaborated with private philanthropic organization Tanoto Foundation to enhance the capacities of teachers and principals in the two schoos – SDN 021 West Balikpapan and SMPN 21 Balikpapan, which respectively have 102 and 72 students. Since 2018, the

Tanoto Foundation, through its PINTAR Program, partnered with the Department of Education and the Ministry of Religion of Balikpapan to improve the quality of teachers and principals across 24 partner schools.



The Mayor of Balikpapan, H.M. Rizal Effendi, S.E. and other government officials were present at the handover ceremony renovated.

In his remarks, Rizal acknowledged that the community had played an important role in supporting this initiative. He expressed gratitude for the continuous commitment of Apical Group and the Tanoto Foundation in assisting the government's in improving public education. "This is also the final and most beautiful gift for me at the end of my term (31/05/2021). This school is now supported by much improved facilities and infrastructure that are able to facilitate learning," he said.



He added that it was rare for companies to use their land for other purposes such as for community development projects, but PT Kutai Refinery Nusantara (KRN) had demonstrate otherwise.

"We thank the Balikpapan Government and the Department of Education and Culture who continue to provide support and motivation in the process of moving this school, and also to Apical Group and its business unit PT Kutai Refinery Nusantara (KRN) for their assistance to our school in the relocation of bridges, procurement of school buses, representative school building facilities and a much better layout than the old school. We hope that the support provided by PT KRN to the schools here will continue," he said.
